

## 2013 VA County Loan Limits

The Department of Veterans Affairs (VA) has issued the 2013 VA County Loan Limits which are used to calculate the VA's maximum guaranty amount for a particular county. These limits apply to all VA loans closed January 1, 2013 through December 13, 2013.

Many of the VA county limits have changed from 2013. HomeBridge has provided a list of the counties that **had an increase or decrease from 2013 limits** below.
