### HomeStyle Renovation Program Overview

- Allows the borrower to obtain a single loan to purchase a property and complete construction/repairs/improvements after loan closing using the “After-Improved” value of the property
- No minimum dollar amount for repairs.
- **Purchase Transactions:** The maximum renovation/repair costs are limited to the **lesser of:**
  - \$200,000, or
  - 50% of the sales price
- **Refinance Transactions:** The maximum renovation/repair costs are limited to the **lesser of:**
  - \$200,000, or
  - 25% of the “after-improved” value
- Manufactured home: Must meet all Fannie Mae eligibility criteria for manufactured homes. Renovation/repair costs cannot exceed the lesser of:
  - \$50,000, or
  - 50% of the “after-improved” value
- All improvements must be permanently affixed to the property excluding kitchen appliances; free-standing kitchen appliances eligible
- Luxury items are eligible (e.g. swimming pools, spas, tennis courts, etc.)
- All renovation work must begin within 30 days of loan closing. The work cannot stop for more than 30 days during the reno process and must be completed within 6 months of loan closing
- An escrow account is established and funds are generally released as work is completed. A maximum of 5 draws are allowed
- A payment of up to 50% of the total up-front material costs identified in the project estimate may be provided to the borrower and contractor, in the form of a check, at loan close to order project materials. A portion of the 50% may be used to pay associated expenses such as design, architect fees, and permits
- All work must be completed by a licensed contractor selected by the borrower. The contractor must be licensed and insured in the jurisdiction where the work will be completed and provide a minimum of three (3) project references similar to the proposed subject project. Homebridge reviews contractor for acceptance. “Self-help” (borrower completes the work) is **ineligible**.
- Hazard insurance must meet Standard Coverage Requirements; refer to the Insurance Quick Reference Guide for details. If the direct renovation costs are  $\geq$  \$75,000 evidence must be provided the insurance company insuring the property has reviewed the bid and appraisal and confirms a hazard insurance policy will be issued
- One (1) general contractor permitted. One (1) specialty contractor allowed with Homebridge approval (foundation, pool, well/septic etc.) Projects with direct hard costs  $\geq$  \$75,000 have additional contractor requirements. Refer to the [Maximum Repair Costs](#) topic for requirements
- A Streamline option is available for renovations with  $\leq$  \$35,000 in repairs. The transaction must be a primary residence or second home and must include a minimum of one (1) energy efficient improvement. Refer to the [Streamline Option](#) topic for details
- The borrower **cannot** receive **any** cash-back
- HomeStyle loans may be combined with HomeReady; the more restrictive of the guidelines apply with the exception of MI which allows the lower MI coverage amounts of HomeReady to be used

Evidence required:             <ul style="list-style-type: none"> <li>- Two months most recent bank or financial statements, all pages.</li> </ul> <p style="margin-left: 40px;">NOTE: If a copy of the canceled deposit check is used to document the source of funds, the bank statements must cover the period up and including the date the earnest money check cleared the bank.</p> </li> <li>• Business funds of a self-employed borrower may be used for down payment, closing costs and reserve requirements subject to the following:             <ul style="list-style-type: none"> <li>- The borrower must be listed as an owner on the account. If the borrower's name is not listed on the business account statement, documentation that the borrower is an authorized signer on the account is required. This applies to all business accounts, including sole proprietorships, when business account funds are being utilized for down payment, closing costs and/or reserves. <b>Assets (cont.)</b>	<ul style="list-style-type: none"> <li>• Large deposits are considered to be a single deposit where any <b>unsourced</b> portion of the deposit exceeds 50% of the combined gross monthly income of the borrower(s). If the deposit includes both sourced and unsourced funds, only the unsourced portion is used to calculate whether the deposit meets the 50% definition. Direct deposits, such as IRS or state income tax refunds, transfer of funds between verified accounts, that are easily identified on the account statement do not require documentation.</li> <li>• Large unsourced deposits must be explained and verified.</li> <li>• Requirements for documenting large deposits are as follows:             <ul style="list-style-type: none"> <li>- If the funds from a large deposit are needed for the down payment, closing costs or reserves on the transaction documentation must be provided that the funds are from an acceptable source. Any undocumented large deposit will be deducted from the amount of verified funds and the reduced asset amount will be used for qualification</li> </ul> </li> </ul> <p><i>Examples:</i></p> <ol style="list-style-type: none"> <li>1. The borrower has a monthly income of \$4,000 and a bank account with a balance of \$20,000. In this example only the \$500 is considered "unsourced" (\$3000 total deposit minus \$2500 tax refund) and is included in the large deposit calculation.              The unsourced \$500.00 is only 12.5% of the borrower's monthly income therefore it does not meet the large deposit definition (50% of the borrower's total monthly qualifying income). In this example, documentation is not required and the entire \$20,000 balance in the borrower's bank account may be used for underwriting purposes.</li> <li>2. The same borrower has a deposit of \$3,000 but only \$500 is documented as the borrower's tax refund (sourced) leaving \$2,500 has unsourced. #### Collections/Charge-offs/Judgments

The following applies to collection and charge-off accounts:

- Past-due accounts (that have not gone to collection) must be brought current.

  - The borrower is not required to pay off outstanding collections or charge-offs regardless of the amount.

- Mortgage must be current for the month closing.
- Copies of rent checks are required to document rental payment history subject to DU Findings. In lieu of rent checks, at the underwriter's discretion the following may be acceptable:
  - A direct verification of rent (VOR) provided by a professional management company, or
  - Copies of money orders

### **Forbearance Plan Policy**

<b>Streamline Option</b>	<p>The Streamline option, which does <b>not require</b> the use of a consultant, is available subject to the following:</p> <ul style="list-style-type: none"> <li>• Property is an owner-occupied or second home, <b>and</b></li> <li>• The scope of work is ≤ \$35,000, <b>and</b></li> <li>• The scope of work includes, at minimum, one energy improvement with an “Energy Star” designation.
