		<ul> <li>Additionally, the following applies:</li> </ul>
		<ul> <li>One of the comparable sales must be outside the project the subject property is located in and be from an MLS, MRIS, MRED, NTREIS, SABOR, GeoData, Comps Inc. or public source (public source Maine/New Hampshire/Vermont only).</li> </ul>
