- **Borrowed Funds – Secured:** Eligible for asset's already owned by the borrower
  - A copy of the Note is required to confirm the terms of repayment
- **Business Assets** are an acceptable source for down payment, closing costs and reserves when the borrower is self-employed and has 25% or more ownership in the business subject to the following:
  - All funds must be documented with the most recent 2-months bank statements
  - The amount of business assets that may be utilized are restricted to the percentage of ownership interest the borrower has in the business.
  - Large deposits (atypical/inconsistent) must be sourced and documented
  - Evidence the withdrawal of funds will not negatively impact the business required. Acceptable evidence is one of the following (N/A ICF option):
    1. **A CPA/EA/CTEC letter, OR**
    2. A **cash flow analysis** based on the following:
      - Determine the business' monthly operating expenses based on either the most recent years tax returns **or** average the deductions using three (3) months business bank statements, **and**
      - Deduct three (3) months' worth of expenses from current business balance to determine available balance and apply the borrower's ownership percentage to the result to determine eligible business assets
  - Any funds transferred into personal accounts prior to the application date are eligible without restriction.  
**NOTE:** Business assets **ineligible** to satisfy reserve requirements on the Asset Utilization option
- **Cryptocurrencies:** Eligible for down payment, closing costs, and reserves. Cryptocurrency must be liquidated and deposited into a U.S. bank/financial institution account. There is **no** seasoning requirement
- **Custodial Accounts:** Eligible if the borrower has complete access to the funds. 529 accounts **ineligible**
- **Foreign funds** eligible for down payment, closing costs and reserves subject to the following:
  - Documentation that provides proof the funds belonged to the borrower for a minimum of 90 days prior to the transfer, **and**
  - Funds must be transferred into a U.S. bank or deposit account, **and**  
**Reminder: Deposits** may be subject to exchange rate/country risk
  - Copy of the wire transfer required  
**NOTE:** On a case-by-case basis Homebridge will consider allowing foreign funds being used to **satisfy reserve requirements** to remain outside of the U.S. in a foreign financial institution subject to Homebridge management review and approval. Refer to [Exhibit A Acceptable Bank/Financial Institutions for Foreign Credit and Assets](#) for a list of eligible foreign institutions.
- **Marketable Stocks, Bonds, and Mutual Funds** (net of margin) that are traded on a major market exchange (NASDAQ, NYSE, AMEX) may be used for closing costs and reserves at 100% of the verified market value minus any outstanding margin loans. Liquation requirements are as follows:
  - If the funds are required for closing (e.g. down payment, closing costs) the liquidation of the funds and the ending balance of the account(s) must be documented
  - If the funds are being used to satisfy reserve requirements, liquidation is **not** required

Assets (cont.)

Asset Eligibility Requirements (cont.)

- **Proceeds from Sale of Real Estate:** The closing of the other real estate transaction must take place prior to or simultaneous with the subject closing and net proceeds must be verified with a fully executed CD/settlement statements.
  - Proceeds from a pending sale may use the equity in the property to satisfy reserve requirements, up to 50%, subject to the following:
    - Transaction must be arm's length purchase
    - The sales contract must be provided listing the seller as the owner (individually or through an entity created for their benefit)
    - The transaction must be closing within 90 days of the subject transaction
    - There can be no outstanding financing contingencies, or evidence contingencies have been cleared
    - An estimated settlement statement, prepared by an attorney or closing agent, confirming the estimated proceeds to the borrower,
    - The borrower must provide a letter attesting to the number and amount of outstanding liens on the property
- **Relocation Benefits:** Eligible for funds to close subject to the following:
  - A copy of the executed buyout agreement to purchase the existing residence required, **and**
  - Any closing costs and points that may be included in the relocation package may be use, however, the borrower must provide funds for prepaid items unless specifically stated in the relocation package, **and**
  - A copy of the fully executed CD/settlement statement must be provided at closing evidencing the sale and release from liability
  - When all of the above requirements are met, the PITIA on the existing residence may be excluded from the borrower's DTI calculation

NOTE: Relocation funds provided towards the borrower's down payment are not eligible
- **Rental or Lease Credits:** Rent/lease credit eligible to meet down payment requirements:
  - Credit for the down payment is determined by calculating the difference between the market rent and the actual rent paid for the last 12 months
  - Market rent is determined by the appraiser in the appraisal for the subject property
  - Only the portion of the rental payment that exceeds the fair-market can be applied to the down payment or closing costs
  - Credits granted to a borrower from a rent with option to buy lease arrangement as closing funds, the following applies
    - The lease agreement must state how the credit will be accrued,
    - The borrower must provide copies of cancelled checks/money orders to evidence history of 12 months, **and**
    - Copy of rental/purchase agreement evidencing a minimum original term of 12 months, and
    - The appraiser must provide comparable rent schedule for the property (FNMA Form 1007)

NOTE: Rental or lease credits are **not eligible** to meet reserve requirements
- **Repayment of a Loan:** A lump sum repayment of a loan is eligible provided the initial loan and the repayment can be verified and documented.
- **Trust Account Funds:** **Eligible** when the borrower has immediate access to the funds subject to the following:
  - A copy of the trust or trust certificate is required, **and**
  - Written documentation of the value of the trust, the conditions under which the borrower has access to the funds, and the effect, if any, the withdrawal of funds will have on the trust income if used in qualifying the borrower must be provided by the trust manager or trustee.

  - **1-4 unit primary residence transaction ONLY; second home and investment transactions ineligible for FTHB**
  - A 12 month documented rental history with 0x30 required (documented with cancelled checks, institutional VOR completed by a management company; **private party/landlord VORs not allowed**). See [FTHB Living Rent Free](#) topic for exception
  - **Payment Shock**
    - Maximum 300% payment shock
  - NOTE:** Refer to [Payment Shock](#) topic for complete details
  - **FTHBs and rent free borrowers ineligible on ICF option**
- **FTHB Living Rent Free:** Eligible, as applicable, subject to the following:
  - **Borrowers living rent free must be living with a family member/relative\***,
  - 1-4 unit primary residence transactions **ONLY**; FTHBs living rent free are **not eligible** on second home and investment property transactions
  - The rent free period is not required to be in the months immediately preceding or during the loan application process (except for the P&L option; refer to the P&L option **ONLY** topic for requirements)
  - A rent free letter, provided by the family member/relative\*, **required**
  - Maximum 45% DTI
  - Required reserves must be borrower own funds
  - 10% minimum borrower own funds contribution required
  - Payment shock requirements **do not** apply to borrowers living rent free (excluding P&L Option, see **P&L Option ONLY** below for requirements)
  - \***NOTE: Fannie Mae family member/relative definition applies:**
    - A relative, defined as borrower's spouse, child, or other dependent, or any other individual related to the borrower by blood marriage, adoption or legal guardianship **OR**
    - A non-relative that shares a familial relationship with the borrower defined as a domestic partner (or relative of the domestic partner), individual engaged to marry the borrower, former relative, or godparent
  - **P&L Option ONLY**
    - The rent free period must be in the months **immediately preceding or during** the loan application process.

- **Non-Occupant Co-Borrowers:** Eligible
  - A family relationship is **not required** as long as the transaction is an arm's length
  - NOTE:** The non-occupant co-borrower **cannot** be the seller of the property, an existing tenant, builder of the property or real estate broker
  - Income and assets are blended
- **Permanent Resident Aliens:** Must provide an unexpired I-551 Permanent Resident Card (aka Green Card) issued by the U.S. Citizenship & Immigration Services (USCIS) **OR** a temporary I-551 stamp on an unexpired foreign passport to verify the borrower has been awarded permanent residency in the U.S.

Borrowers may hold title as follows:

- **Fee Simple:** Vesting in the name of individual(s)  
**NOTE:** Title held as tenants in common requires the ownership percentage **be equal; if ownership percentage is unequal the transaction is ineligible**
- **Non-borrowing Spouse:** All applicable state laws regarding waiving any property rights must be followed when the transaction involves a non-borrowing spouse with an interest in the property
- All individuals signing the loan application are considered borrowers and all borrowers must sign the Note
- Additional individuals on the CD/settlement statement are not required to sign the Note (applicable state laws apply)
- **Limited Liability Corporation (LLC) and Corporations.** Title held in an **LLC or Corporation REQUIRES HOMEBRIDGE MANAGEMENT REVIEW AND APPROVAL.** LLC and Corporation eligibility requirements are as follows:
  - **Eligible on investment properties only**
  - The LLC/Corporation must be legal in the state where it is formed **and** created to manage rental properties **only**,
  - Title may be held in the LLC/Corporation, but the loan application must be in the individual borrower's name(s)
  - All borrowers must sign the Deed of Trust/Mortgage as individuals and as authorized signers of the LLC/Corporation (debt will be reported on the borrower's individual credit report)
  - A maximum of four (4) owners/members of the LLC/Corporation are allowed **and** owners/members must be beneficial owners of the property
  - All owners/members of the LLC/Corporation must be borrowers on the transaction
  - Copies of **all of the** following must be provided:
    - **Articles of Organization** (LLCs) or **Articles of Incorporation**, or equivalent (Corporations), **and**
    - **Operating Agreement** (LLC **only** - must provide term of the LLC and the members authorized to encumber the LLC as guarantors). Organizational meeting minutes may be required if the Operating Agreement does not clearly identify the powers of the managing partners, **and**
    - **By-Laws**, including all amendments (Corporations **only**)
    - **Unanimous Consent & Resolution to Borrow**, which must include the lender's name, loan amount, and property address, **and**
    - **Form SS-4, Application for Employer Identification Number**, with Tax ID number listed, **and**
    - **Certificate of Good Standing** from the applicable Secretary of State's office (print out from secretary of state website **not** acceptable), dated within 60 days of the Note date
  - The Note must be signed by the borrowers in both their individual capacity and as a member and/or manager of the LLC/Corporation. All members of the LLC/Corporation must sign the Note as member of the LLC/Corporation, in addition to any other signature requirements.
  - The mortgage/deed of trust/security instrument must be signed by all members of the LLC/Corporation as individuals **and** as authorized signers of the LLC/Corporation

### Credit Report/Scores

- Minimum credit score requirements vary by LTV/loan amount; refer to the [LTV/Loan Amount](#) matrices for requirements
  - **The credit report must include the borrower's full social security number; partial SSNs are not acceptable**
  - If the borrower has a credit freeze, the credit freeze must be removed, and the credit information obtained.
  - Foreign credit reports are not eligible
  - **Individual Borrower's Credit Score**
    - Each borrower is **required** to have a minimum of two (2) valid scores. If each borrower does not have two (2) valid credit scores the loan is **ineligible**. An individual borrower's representative credit score is determined as follows:
      - Three (3) valid scores, the middle score is used
      - If two scores, the lower of the two is used
  - **Representative Score for Loan:**
    - The lowest middle score of all borrowers is the qualifying credit score
  - Homebridge will accept a credit report, in the broker's name, from any Fannie Mae acceptable credit vendor.
  - A tri-merged credit report or Residential Mortgage Credit Report (RMCR) is required for all borrowers
    - Borrowers with only two (2) credit bureaus reporting are acceptable if that is the extent of the information available
    - Borrowers with only one (1) bureau reporting are **not eligible**
  - Borrowers must sign a debt certification form at loan closing verifying they have not opened any new tradelines
  - The credit report should include verification of all credit references provided on the loan application
  - **Any inconsistency in the social security number(s) reported require a signed, written explanation from the borrower.**
  - The credit report must certify the results of public record searches for each city the borrower has resided in during the last 2 years.
  - **Credit Inquiries**
    - The borrower(s) must address, in writing, **all** credit inquiries indicated on the credit report within the previous 120 days. The LOE must reference the creditor name (e.g. Wells Fargo, Bank of America, etc.) and indicate the reason for and result of the inquiry (i.e. was new credit obtained or not). If new credit was obtained, a verification of that debt must be provided, and the borrower must be qualified with the monthly payment.
- Examples:**
- **Acceptable Response:** Chase, Wells & Bank of America credit pulled while searching for a mortgage; no credit was obtained.
  - **Unacceptable Response:** "We did not accept any credit for the inquiries listed on our credit report: or "We did not accept any credit from Chase, Wells & Bank of America" (neither response specifically addresses both the inquiry and disposition).
- If additional debt was obtained or discovered or the borrower's income is reduced after the underwriting decision was made the following applies:
    - The additional debt(s) and reduced income must be applied and determined if the loan still qualifies,
    - If there is new subordinate debt on the subject property, the loan must be re-underwritten, and
    - The final loan application signed by the borrower(s) must include all income and debt verified, disclosed or identified
  - The credit report cannot be more than 120 days old as of the Note date

**Debts Paid by Others**

Debt the borrower is obligated on that is being paid by others may be excluded from the DTI calculation subject to the following:

- **Non-Mortgage Debt**

Non-mortgage debt includes, but is not limited to, auto loans, lease payments, student loans, revolving debt, etc. The following applies to non-mortgage debt:

- Documentation the other party has been making the payments for the prior 12 months. Acceptable documentation includes bank statements, cancelled checks etc.
- The debt must be paid as agreed **with no history of delinquent payments**
- The party making the payments **cannot** be an interested party to the transaction

- **Mortgage Debt**

- The party making the payments must be obligated on the mortgage
- Documentation the other party has been making the payments for the prior 12 months. Acceptable documentation includes bank statements, cancelled checks, etc.
- The debt must be paid as agreed **with no history of delinquent payments**
- The borrower is not using rental income from the applicable property to qualify
- The property must be included in the total count of financed properties

**Debts Paid by Business (Self-Employed Borrowers)**

- Debt(s) paid by the borrower's business **may be excluded** from the DTI calculation as follows:

- Documentation provided the business has paid the debt for the previous 6 months. Acceptable documentation includes business cancelled checks, bank statements, tax returns or cash-flow analysis etc.)

**NOTE: If the debt is mortgage debt and the borrower is personally obligated on the mortgage debt it cannot be excluded**

- There can be no history of delinquency
- Debt paid by the borrower's business **must be included** in the DTI calculation if:
  - There is any history of delinquency,
  - The borrower cannot provide acceptable evidence (see bullet point above for acceptability),
  - Evidence is provided however the Homebridge underwriter analysis does not reflect any business expense related to the debt

**Deferred Installment Debt**

- Deferred installment debt must be included in the DTI calculation. Accounts in forbearance considered on case-by-case basis subject to Homebridge management review. If the credit report does not indicate a payment amount due at the end of the deferred period, the following is required:

- Documentation that includes the payment amount after the deferment period (payment letter, forbearance agreement, etc.)
- If a payment cannot be determined, 1% of the outstanding balance will be used

**Installment Debt (Including Mortgages)**

- Installment debt must be included in the borrower's DTI calculation/debt service when there are 10 months or more payments remaining.

**NOTE: Lease payments must be included in the DTI/debt service regardless of number of payments remaining.** Lease payments cannot be paid down or paid off

- Installment debt with < 10 months of payments remaining may be excluded from the DTI as long as the borrower has sufficient assets to make the remaining payments
- Installment debt may be paid down to < 10 months to exclude however the source of funds must be documented and sourced
- If the payment is not on the credit report, documentation of the current payment must be provided
- If a payment will be changing within 6 months (i.e. an ARM or interest-only loan) the new payment must be used for the DTI calculation/debt service
- Installment debt that will be paid in full prior to closing may be excluded from the DTI calculation/debt service. Documentation (credit supplement or direct verification from the creditor) must be obtained to evidence the debt has been paid in full is required and the source of funds must be documented

**Debt-to-Income (DTI) Ratios (cont.)**

**Installment Debt (Including Mortgages) (cont.)**

- If the installment account is to be paid off at closing, the payoff must be shown on the Closing Disclosure. **If the debt is paid off with any portion of the allowable cash-back on a rate/term transaction, the loan will be considered a cash-out transaction**  
**NOTE:** Texas 50(a)(6) loans, the funds must be disbursed **directly to the creditor** by the closing attorney/title company
- An authorized used account may be omitted from the DTI calculation provided there is no evidence the borrower is paying the account. A credit supplement, showing the account removed, will be obtained

**Loans Secured by Financial Assets**

- The payment on a contingent liability (loans secured by the borrower's financial assets such as life insurance, 401(k) account, CDs, etc.) are not required to be included in the DTI calculation. A copy of the loan instrument showing the borrower's financial asset as collateral is required
  - If the borrower is using the asset to meet reserve requirements the amount of the loan will be deducted from available funds
- Payments on loans that are secured by a borrower's specific liquid financial asset(s) may be excluded from the DTI calculation when the repayment of the loan rebuilds the asset and current verified balance in the account (or value of the asset) is sufficient to fully payoff the loan

**Relocation Benefits**

The PITIA payment on the existing property is not required to be included in the DTI calculation when the borrower is using a relocation package. Refer to the [Relocation Benefits](#) topic in the Asset section for requirements when excluding the DTI.

**Revolving (Including HELOC)**

Revolving debt is considered part of the borrower's recurring monthly debt. Revolving debt includes credit cards and personal lines of credit. Revolving debt is subject to the following:

- The minimum required payment stated on the credit report or current account statement should be used in DTI calculation
- If no payment stated on the credit report or current statement is unavailable the **greater of 5%** of the current balance **OR \$10** will be used to determine the monthly payment (excluding HELOC; if HELOC use 1%). If no balance, no payment is included
- 30 day accounts require the account to be deducted from available liquid assets OR use 5% of the balance as a payment
- If the revolving account is to be paid off prior to or at closing, a monthly payment is not required to be included in the debt ratio/debt service. The account does not need to be closed as a condition of excluding the payment from the borrower's debt ratio.
- If the revolving account is to be paid off prior to closing, documentation that the debt was paid in full and source of funds must be provided and verified
- If the revolving account is to be paid off at closing, the payoff must be shown on the Closing Disclosure and documentation provided that the borrower provided the funds necessary to pay off the account(s). **If the debt is paid off with any portion of the allowable cash-back on a rate/term transaction, the loan will be considered a cash-out transaction**  
**NOTE:** Texas 50(a)(6) loans, the funds must be disbursed **directly to the creditor** by the closing attorney/title company
- An authorized used account may be omitted from the DTI calculation provided there is no evidence the borrower is paying the account. A credit supplement, showing the account removed, will be obtained

**Sale of Departing Residence**

- If the borrower is under a **non-contingent** contract to sell their departing residence the PITIA for the departing residence may be excluded from the DTI calculation **if the borrower has an additional 6 months reserves based on the departing residence PITIA**
- If the borrower is not under a contract to sell or has a contract to sell with contingencies that have not yet been released the departing residence will be treated as an investment property and the PITIA payment will be included in the DTI calculation

### Foreign National Borrowers (cont.)

#### **Borrower Eligibility**

- The borrower must provide a copy of a current, valid foreign passport with a photograph as evidence they are present in the U.S. legally, **AND**
  - A current, valid visa with a photograph and signature except as noted under the **Visa Exception** topic below, **OR**
  - Form I-797, **Notice of Action**, with valid extension dates, **and** Form I-94, **Arrival/Departure Record**

**NOTE:** A list of non-immigrant visa types is available on the [U.S. Department of State](#) website

- **Visa Exception:** A visa is **not** required for:
  - Canadian citizens
  - Borrowers who are citizens of a country listed on the U.S. [State Department's Visa Waiver](#) program page. The borrower must provide a current, valid passport, with a photograph.
    - A printout of the current participating countries, with the borrower's country of origin highlighted, must be included in the loan file
- If the foreign national borrower is a co-borrower with a U.S. citizen, the requirements in this topic apply.
- All borrowers must file an IRS Certificate of Foreign Status, (IRS form W-8BEN). A copy of the Certificate must be maintained in the loan file

#### **Assets**

- Funds required for down payment, and closing costs **must be transferred to a U.S. financial institution prior to closing and** sourced for the previous 90 days. Any foreign asset statements provided must be in both the original format (home country language and currency) and as a version translated to English. Refer to the [Translation Requirements](#) topic for complete details
- Foreign funds being used for asset qualification or to satisfy reserve requirements may remain outside of the U.S. in an approved foreign financial institution subject to Homebridge management review and approval. If not approved, the funds must be moved to an account in a financial institution located in the U.S. prior to closing and meet the requirements above. Refer to [Exhibit A Acceptable Bank/Financial Institutions for Foreign Credit and Assets](#) for a list of eligible foreign institutions.

#### **Credit Requirements**

- Foreign National borrowers are **not** required to have a social security number; if they **do not** have a social security number a credit report and credit score **are not required**.  
**NOTE:** Borrowers without a U.S. credit score maximum 65% LTV
- When the Foreign National borrower **does not** have a social security number, the following is required:
  - Two (2) credit reference letters from a financial institution from borrower's country of origin, written or translated into English. Refer to [Exhibit A Acceptable Bank/Financial Institutions for Foreign Credit and Assets](#) for a list of eligible institutions
  - The letters may include non-traditional credit sources (e.g. utility company, etc.)
  - The letters must reference the borrower's time as a customer and that the borrower is in good standing.
- If the Foreign National borrower **does** have a social security number, the following applies:
  - A U.S. **or** international credit report must be obtained, and the borrower's credit reviewed
  - The U.S. or international credit report must be reviewed to ensure the borrower meets trade line requirements; the borrower's credit history cannot be disregarded
  - The borrower's credit history (e.g. combination of credit report and supplemental credit references, if applicable) including payment history and any derogatory credit, must meet the applicable credit requirements; refer to the [Derogatory Credit](#) topic for requirements.
- Borrowers with U.S. mortgages/rental verifications require 0x30 in previous 12 months

**Foreign National Borrowers (cont.)**

**Liabilities**

- Borrower must provide a schedule of real estate owned listing, as applicable, property type, property value, and as applicable, rental income, mortgage amount, mortgage payment, and taxes, insurance, and common charges. **All U.S. liabilities must be considered.**

**NOTE:** Foreign liabilities, including carrying costs on foreign properties, are not required to be documented or included in the underwriting analysis.

**Additional Requirements Specific to Foreign National Transactions**

- A **World Compliance** search is required for **all** borrowers. The World Compliance search will be performed by Homebridge management. Any alerts must be addressed and cleared. If a borrower cannot get a clear World Compliance search the loan is **ineligible**.
  - Borrower cannot be on the U.S. Department of Treasury Sanctions list and **must have** a clear OFAC search
  - Borrowers from OFAC sanctioned countries are **ineligible**
- A signed **Automated Clearing House (ACH) Agreement** is required on all Foreign National transactions. The ACH Agreement will be provided by Homebridge with the closing docs for borrower signature. The ACH agreement facilitates the transfer of electronic funds and must be tied to a U.S. bank account. The account must:
  - Be in the borrower's name (proof required)
  - The borrower must document that the account has, at minimum, funds to cover the first month's loan payment
- **Translation Requirements:** All foreign documentation provided must be in its original form. The documentation must be translated to English by a certified translator. The translator's certification documentation is required and **is subject to Homebridge management review and approval**

- 1-4 unit primary residence
- 1-unit second home
- 1-4 unit investment property (investment **ineligible** on Asset Utilization option)
- Condominiums **Fannie Mae Warrantable** (attached/detached). The following review types are eligible:
  - Fannie Mae **Full Review** completed by the Homebridge Condo Department, **or**
  - Fannie Mae **Limited Review** completed by Homebridge, **or**
  - Fannie Mae **Project Eligibility Review Service (PERS)** approval. Reminder, Homebridge **does not** obtain PERS approvals; project must currently have a PERS approval that is valid through the Note date
- **NOTE:** The loan file must include the HOA/management company contact information, the amount and frequency of the HOA dues and evidence of current status of HOA dues
- Condominiums **Non-Warrantable**; refer to the [Properties – Eligible: Non-Warrantable Condominiums](#) topic for requirements

    - o Document that a search of the MLS was performed to ensure the property is not listed with a different realtor,
    - o Documentation that confirms the borrower is currently occupying the subject property (owner-occupied only)
  - **If the property was listed for sale in the previous three (3) months,** the LTV will be based on the **lesser of:**
    - The list price, **OR**
    - The appraised value, **and**
  - **If the property was listed for sale in the previous six (6) months, the borrower must provide an acceptable letter stating their intent to retain the subject property**
- A rate/term transaction is eligible for the following:

- The LTV will be calculated using the **lower of:**
  - The purchase price, or
  - The appraised value unless the appraiser can justify and support an increase in value

### Texas Section 50(a)(6) aka Texas Equity

Texas Section 50(a)(6) loans (Texas Equity) is a cash-out refinance transaction. A current Texas Equity loan may be refinanced as a rate/term refinance subject to specific requirements. Refer to the [Texas Equity Being Refinanced as a Rate/Term Transaction](#) topic for details.

#### Program Option and Product Eligibility

- Texas Equity loans are eligible on Full Doc, Bank Statement, Asset Utilization, 1099 Only, and P&L Only options; **not applicable to the Investor Cash Flow option** (ICF is investment properties only and TX Equity only applies to primary residence)
- Fixed rate; **interest-only is not eligible**
- Transactions must meet all applicable TX law

#### General Requirements

- Maximum 80% LTV/CLTV
- The property is the borrower's primary residence and is classified as the borrower's homestead under Texas law.
- The property is a 1-unit single family residence, PUD, condo
- All borrowers must occupy the property; non-occupant co-borrowers are not allowed
- All borrowers must be on title
- Existing subordinate financing may be resubordinated excluding a HELOC or a reverse mortgage, **which must be paid off**
- Interest-only is **ineligible**
- Power of attorney is **ineligible**
- Loan must close in the closing agent's office (title company/attorney's office); mobile notaries are not allowed
- The borrower(s) must receive a copy of the final 1003 along with the CD for review a minimum of 24 hours prior to closing
- Deed of Trust: Trustee must be completed on the Security Instrument (must be a Texas resident and is typically an attorney)
- All married parties, regardless if on the loan or not, must sign the Deed of Trust and Notice of Right to Cancel (Texas is a community property state)
- Fees are limited to a maximum of 2%. The following are **excluded** from the limitation:
  - Prepaid and bona fide discount points (requires Election to Pay Discount Points affidavit)
  - Escrow reserves
  - Insurance premiums,
  - Property taxes paid at closing,
  - Per diem interest,
  - Homeowner's insurance,
  - Title insurance premium and endorsement fees,
  - Survey costs, and
  - Third party appraisal fees (appraisal management fee is not excluded)
- A survey is required and must document the following:
  - Lot size, **and**
  - The homestead property and any adjacent land are separate parcels, **and**
  - The homestead property is separately platted and subdivided lot with full ingress/egress, **and**
  - The homestead is a separate parcel meeting acreage requirements (see [Property Requirements](#) below), **and**
  - The property is served by municipal utilities, fire, and police protection (if urban)
- A Texas Land Title Association (standard or short form) title policy including a T42 and T42.1 endorsement required.
- Self-employed borrowers operating a business from the subject property require a T42.1 endorsement **without exception or deletion**

**Texas Section 50(a)(6) aka Texas Equity (cont.)**

- The title policy cannot include language that:
  - Excludes coverage for a title defect that arises because financed origination expenses are held not to be “reasonable costs necessary to refinance” or
  - Defines the “reasonable costs necessary to refinance” requirement as a “consumer credit protection” law since the standard title policy excludes coverage when lien validity is question due to a failure to comply with consumer credit protection laws

**Property Requirements**

- Property is the borrower’s homestead
- Property must be residential in nature; properties used for agricultural purposes are **not** allowed
- Properties with an agricultural designation are eligible **with a 5% reduction to the LTV**
- All separate structures must be included in the homestead exemption
- Only the parcel designated as the homestead parcel may secure the loan and the market value for the LTV calculation can only be assessed on that parcel.
- The homestead parcel, as identified on the county appraisal district records, must include ingress/egress to a properly identified public road.
- **Urban Properties:** An urban property is defined follows:
  - Property **is** located within municipal boundaries, a municipalities extraterritorial jurisdiction, or a platted subdivision, **and**
  - Property is served by police and fire (fire may be paid or volunteer), **and**
  - Property has a minimum of **three (3)** of the following services provided by the municipality or under contract to a municipality:
    - Electric,
    - Natural gas
    - Sewer,
    - Storm Sewer,
    - Water
  - **Maximum 10 acres**
- **Rural Properties:** A rural property is defined as follows:
  - Property is **not** located within municipal boundaries or a municipalities extraterritorial jurisdiction, **OR**
  - The property **is** located within one of those areas, but it is **not** served by police or fire protection provided by the municipality/under contract with a municipality, **and**
  - Property has less than three (3) of the following services are provided by a municipality (directly or indirectly):
    - Electric,
    - Natural gas
    - Sewer,
    - Storm Sewer,
    - Water
  - **Maximum 10 acres.** Properties that exceed 10 acres, up to the maximum of 20, must be common/customary for the area and be the highest and best use of the property

**Non-Borrowing Spouse Requirements**

A non-borrowing spouse will be required to sign all of the following documents (as applicable):

- Notice Concerning Extension of Credit
- Security Instrument (including any Riders)
- Federal Truth-in-Lending Disclosure Statement
- Right of Rescission Notice
- Discount Point Disclosure
- Acknowledgment of Fair Market Value
- Premium Pricing Disclosure
- Notice of Presentation of CD One Day Before Closing
- Texas Home Equity Affidavit and Agreement
- Owner’s Affidavit of Compliance
- Receipt of Copies of Documents
- Certificate of Non-Cancellation of Loan

- Transactions that allow assumptions
- Property flips (not meeting policy in these guidelines)
- A refinance transaction where the property is currently listed for sale
- Transactions with PACE/HERO program originated prior to July 6, 2010
- Transactions with a PACE/HERO loan (loan must be paid off)
- High cost mortgage loan
- Subordinate liens with negative amortization
- Refinance of an unseasoned restructured loan or short refinance loan
- Renovation or rehabilitation loans
- Transaction consisting of an assignment of the sales contract
- Transaction that include the use of privately funded loans for the purpose of securing assets for the transaction
